Tax Effective

Sophisticated Investors can invest up to \$1 million in a qualifying Early Stage Innovation Company (ESIC) and qualify for the following benefits;

1. A tax offset equal to 20% of their investment in an ESIC up to a maximum tax offset of \$200k; and
2. So long as the shares are held for 12 months or more, any capital gain arising up to the 10th anniversary shall be exempt from tax.
